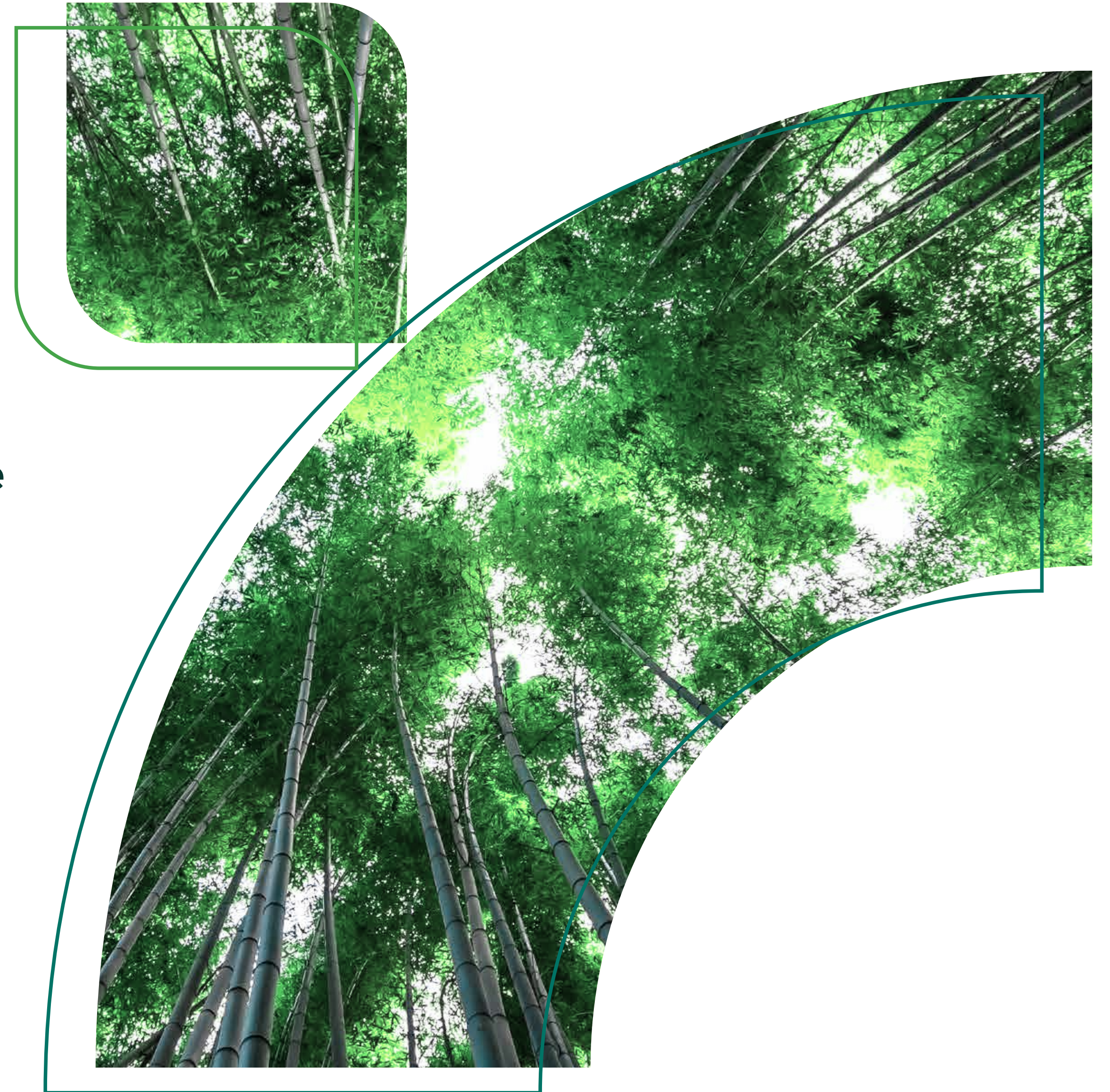

Collection and transportation of hazardous medical waste



Pharmaceutical waste

Collecting pharmaceutical waste such as expired medications, contaminated drugs, and medications that have been discarded due to poor storage or damage



Sharps waste

Collecting and transporting contaminated surgical tools such as needles, syringes, scalpels, and other sharp objects that pose a threat to public health



Infectious waste

Collecting and transporting waste contaminated with viruses or bacteria from hospitals, clinics, and specialized centers. This waste includes biological tissues, blood, and contaminated surgical materials



Biological waste

Collecting waste generated from scientific research or biological diagnostics, such as contaminated biological samples



Chemical medical waste

Transporting harmful chemicals used in medical laboratories, including toxic chemical solutions and flammable materials

Gaseous and liquid waste

Collection and transport of liquid waste like used oils and toxic substances generated from industrial production processes



Oily waste

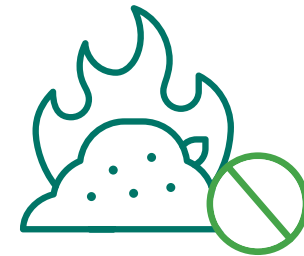
Collection and transport services for oily waste from oil and gas plants, gas stations, and industrial maintenance facilities



Toxic waste

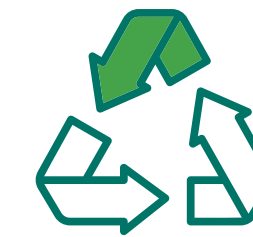
Collection and transport of toxic waste generated from chemical processes in factories, such as acidic solutions, alkalis, and other hazardous materials
